

Sports Ground, Village Hall, and a resident's land.


These essentially said, "Parking at your own risk", to hopefully avert any claims.

Hampshire County Council (HCC) is consulting on proposed changes to the above services. The consultation runs from **Monday 30 May** until **Sunday 24 July 2022** and seeks views on the proposed approach, the impacts that may arise as a result and invites any alternative suggestions.

We would appreciate your input, as well as your support in promoting this through your own communication channels to your members or communities to make them aware of their opportunity to comment.

The proposals seek to continue to deliver effective services, within a reduced budget, and help make around £800,000 p.a savings by April 2023, by:

- making operational changes to supported passenger transport services e.g. supported bus services, Dial-a-Ride, Call & Go and Taxishares
- removing some enhancements to the Concessionary Travel Scheme; and
- increasing the contributions users pay for some services

There are no specific routes/services selected for reductions or changes. The County Council will review data relating to passenger journeys, the cost of providing particular journeys or services, and passenger and stakeholder feedback gathered through the consultation, in order to identify where resources could be used more effectively and where services could be adjusted with minimal impact on service users.

Feedback will inform recommendations to the Executive Lead Member for Transport and Environment Strategy for decisions to be made in November 2022.

# Ref: Planning for the Future: White Paper August 2020

Owslebury Parish Council would like to make clear to you its grave concerns about the proposals in the above White Paper. We were an integral part of the ADD campaign set up to oppose the Eastleigh Borough's planned growth options to bring a potentially catastrophic development next to our parish. These would have bought major increases in traffic volumes to already overloaded country lanes, as well all the other impacts, such as noise, pollution, and habitat destruction that come with traffic.

This plan demonstrated how badly the current system can fail the countryside. It failed to gain the support of affected communities and did not address ecology and biodiversity issues. We were very fortunate that the planning inspector heeded ADD's objections and

prevented the growth options from going ahead. Had the proposed streamlining in the White Paper been in place, the plan would have been passed without the concerns being addressed.

ADD have made a significant representation to the public consultation on what we would see as major defects in the White Paper. Particularly in the way the numbers of houses required is calculated, and the way infrastructure responsibilities are addressed. We fully support the ADD submission.

CPRE has expressed concerns that the proposals diminish local democracy by restricting community engagement. Surely the current COVID problems tell us local rather than central actions sort out issues far more effectively.

### The Woodland Trust has stated that -

- 1. Decisions must be made on accurate nature data
- 2. Nature protection policies and standards must not be weakened, and any proposed
- 3. "Wildlife recovery and people's easy access to nature must be at the heart of planning reform
- 4. Nature protection policies and standards must not be weakened, and assessment of environmental impact must take place before development is permitted.
- 5. We must address ecological and climate crises by protecting land put into recovery.
- 6. People and local stakeholders must be able to engage with the planning system at points where it is meaningful to them and sufficient information is available to understand the impacts on nature and on local communities.

# We feel the key points that this White Paper fails to address are

- 1. Developers land banking and only developing at a rate to prioritise shareholder
- 2. Affordable housing must become the dominant priority, and developers must be made to justify any exceptions to the local community before they are agreed
- 3. Greater use must be made of Brownfield sites. We note that CPRE have calculated that housing could be built on these sites that would meet Government targets.
- 4. Local knowledge and experience being allowed address legitimate concerns.
- 5. Lessons on working from home over the last 6 months which will surely impact where houses should be built in the future

CPRE has proposed a Greenbelt for South Hampshire. We support this as many of the green spaces (outside South Downs National Park) close to our communities are ill protected. A much better 'joined up approach' is needed is needed to protect these sites. No proper framework for enacting this is in the White Paper. An example of the needs is that raised by ADD wrt to the Eastleigh plan – whereby surface water could have drained into the River Itchen, and roads would have cut the sites off from one another.

So we ask you on behalf of our community to –

 Ensure strong local involvement in the Planning Process, both strategic and operational

- 2. Raise the need for Affordable Housing so that developers cannot 'buy' their way out of its provision
- 3. Ensure that congestion, pollution and climate are issues that have to be addressed and resolved before any significant development plan can be approved.

# Review of the South Downs Local Plan

I am writing to you about the review of the South Downs Local Plan and to ask for your help in preparing it. The National Park Authority would like to work collaboratively with its town and parish councils to deliver the Local Plan Review. The South Downs National Park needs properly managed development that conserves and enhances the natural beauty, wildlife and cultural heritage for which it was designated. The original Local Plan was adopted in July 2019. The National Park Authority has made the decision to start a review in line with Government policy and in order to deliver more through planning on its corporate priorities of addressing the Climate Emergency, Nature Recovery and creating a National Park for All. It will be a review and not a completely new plan. It will be done under a challenging financial environment, with a three year flat cash settlement from the Government for the National Park Authority at a time of inflation and fast rising costs. It will also be done at a time of national changes to planning with the recent publication of the Levelling Up and Regeneration Bill. Here is a link to the full Authority report on the Local Plan Review.

The South Downs National Park covers 1,600 km2 of England's most iconic lowland landscapes and the National Park Authority is grateful for the local expertise provided by its town and parish councils. There are three evidence based studies supporting the Local Plan Review, which we are asking your input on:

- I. We are launching a Call for Sites in July 2022 and would be grateful if you sent in details of sites you have local knowledge of, which may be available and suitable for a range of uses including new homes, employment and renewable energy. Full details will be posted on our website shortly about the sort of sites we are interested in and how to make a submission.
- 2. We will be starting work on reviewing our Settlement Facilities Study, which lists the number and type of facilities and services provided in individual settlements across the National Park. This study helps to inform the Authority of the sustainability of individual settlements. A proforma for you to fill out and return to us will be sent out shortly.
- 3. A large number of Local Green Spaces are already designated in the Local Plan and Neighbourhood Development Plans (NDP). If you think there are any further green spaces in your town or parish that merit designation please fill out the Local Green Space proforma that will be sent out shortly.

As part of the Local Plan Review, we will be looking at development need across the National Park and for individual settlements. We will then be seeking development sites to meet this need through our Land Availability Assessment (LAA). Government policy states

that we do not have to meet our objectively assessed development need in full, because we are a National Park, but we should not leave any stones unturned looking for suitable sites. We will allocate sites for a range of uses in our Local Plan Review and will work collaboratively with you in a number of ways. We will arrange 121 meetings with the town and parish councils of the following main settlements: Lewes, Petersfield, Midhurst, Easebourne, Liss, Petworth and Lewes. We will also arrange a virtual workshop for all our town and parish councils with optional 121 sessions (resources permitting) this winter to talk specifically about housing provision figures and the findings of the LAA. This workshop will be open to all town and parish councils both wholly and partly in the National Park. Following on from this we will invite town and parish councils to submit relevant local information on sites that officers can take into consideration in the allocation process. Your comments will help shape potential allocations in your parishes.

There are forty NDPs currently made part of the development plan of the National Park. Regrettably we will only be able to offer feedback at the statutory stages of preparing an NDP namely pre-submission and submission. Some technical support and funding is available from Locality and details can be found on their website. Rather than prepare an NDP for your parish/town we would encourage you to work collaboratively with us on our Local Plan Review. If your parish/town council is designated as a qualifying body, you may also be interested in preparing a Neighbourhood Priorities Statement to summarise the principal needs and prevailing views of your local community. These were identified in the Levelling Up and Regeneration Bill and further details are awaited on these from the Government. In the interim, we will provide a proforma for town and parish councils.

The intention is to publish the draft Local Plan Review with allocations in autumn 2023 when all the town and parish councils will be encouraged to submit formal representations. There will also be a formal Pre-Submission consultation the following year. Leading up to the first consultation here are the main opportunities for you to feed into the Local Plan Review:

- Up to 30 September 2022 to respond to the Call for Sites, Settlement Facilities Study and Local Green Spaces
- Larger settlement meetings (virtual) to be held in November 2022
- Workshop for all town/parish councils with optional 121 surgeries to discuss development provision figures, interim findings of the LAA, Settlement Facilities Study and Local Green Spaces to be held in December 2022
- Up to 31 January 2023 to feedback on the workshop

# Good afternoon,

We are pleased to confirm that on the 5 July we launch our six-week consultation on the Hampshire Water Transfer and Water Recycling Project, a major component of the wide-ranging Water for Life – Hampshire programme.

This project will ensure we can take less water from the sensitive chalk streams of the River Test and River Itchen during a drought, while maintaining essential supplies.

The consultation, which ends on 16 August, outlines our proposal to:

- Build a new water recycling plant south of Havant and use an innovative technology to turn
  treated wastewater into recycled water. The water would then be transferred via a new
  underground pipeline to the Havant Thicket Reservoir so there is more water available for
  use during a drought.
- Build a new underground pipeline to transport water from the reservoir to Southern Water's
   Otterbourne Water Supply Works, where it will be treated further to become drinking water.

These proposals are separate from the current, approved plans for Havant Thicket Reservoir and are subject to further consultation and planning approvals.

The consultation focuses on our proposed pipeline corridors. These are areas of land within which our underground pipes will be routed to transfer water to and from our proposed water recycling plant, and between Havant Thicket Reservoir and Otterbourne Water Supply Works. These areas also include sites where above-ground infrastructure (such as pumping stations, break pressure tanks, construction compounds, access routes and areas for environmental improvements) could be located. We have also shared more information about the innovative water recycling technology being proposed, including details of how it will work, how it helps achieve the objectives of the overall Water for Life – Hampshire programme and how it may become a blueprint for rolling out the technology in other parts of the UK.

People can have their say via an <u>online portal</u>, at several drop-in sessions being held along the potential route of the pipeline or via a series of online webinars. Reference copies of the consultation materials will also be available at several local libraries and other venues along the potential pipeline route – see attached for further details.

Following the close of this public consultation, we'll consider all the feedback we receive, alongside further technical and environmental work, as we work to develop a more detailed design for the project. We'll present this more detailed design, alongside our preliminary environmental work, at another consultation in 2023, during which people will have an opportunity to provide further feedback. In addition to consulting on our Hampshire Water Transfer and Water Recycling Project, we are undertaking a statutory consultation on our draft Water Resources Management Plan for 12 weeks from July. This plan looks at least 50 years ahead and identifies how we will secure water resource for the future across our region.

The plan is being informed by a regional plan being developed in partnership with Water Resources South East and the other water companies that operate in South East England.

Water Resources South East published its emerging regional plan for consultation in January 2022 and we have used this plan to develop our draft Water Resources Management Plan.

Water Resources South East is currently developing its draft best value regional plan which they will consult on in autumn 2022. Following publication of the draft best value regional plan, we'll update our draft Water Resources Management Plan. If our updated plan is materially different to this one, we'll re-consult on it in early 2023.
