42/25 INFORMATION EXCHANGE AND AGENDA ITEMS FOR THE NEXT MEETING

Cllr North advised that he had spoken to the planning consultant on the government removing Bio Net Gain (BNG) credits from any new planning applications and they advised that the government had not made any mention of removing BNG from planning applications in the near future. The thoughts are this would not happen until the summer.

Therefore, Cllr North asked the committee if the council should still go ahead with applying for planning permission for the pavilion.

The committee **Resolved** unanimously to carry on with the application as it will probably take until the summer for the application to be submitted.

Cllr North advised that the Sports Club have engaged Active8 for a full programme of sports starting from May. The sports club will be starting to promote these activities soon.

The sports club have also signed up for the wildcats which is supported by the FA and hope to have another Owslebury sports day and a social cricket match. They hope to get the cricket team under the new sports club this year.

There was some discussion on the sports field greenkeeping and that the sports field needs a tidy up before the spring. The Clerk suggested to meet with the greenkeeper to go through the councils' expectations for the sports field from Spring to Autumn. The committee asked the Clerk to set up a meeting with the greenkeeper.
